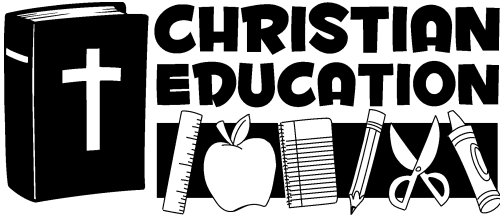

Property Committee Annual Report



We have had a very busy year keeping our property in repair and with new projects.

We first hired a new janitor and got him oriented to his duties.

On Easter morning, we had a break in with property damage which we had repaired and filed a claim with the Insurance Company. We did receive enough money to cover our losses. We also had some vandalism in the parking area with broken lights and some car damage to deal with.

We have received approval for a new unisex restroom, handicapped accessible. This was cheaper than remodeling the present restrooms.

Also, we will be replacing the lights in the Sanctuary.

In March, we will be asking your permission for two projects – constructing a pavilion east of the church, and installing a security and smoke/fire detection system. These projects are needed for the advancement of the congregation and protection of our property and personnel. The cost of these projects will be paid for with funds from the Bequests.

We try to keep up with emergency repairs at all times. If you see something that needs attention, tell us, and we will look into it.

Future plans are for redoing the parking lot as soon as the Township officials tell us where the new sewer line will be placed.

We do not hire out all of the repairs as we are able to do some of them ourselves.

Social Ministry

2007 was an active year of giving for our Social Ministry program and supported our mission to reach out and support one another.

First, let's highlight two of our fund raising events, both of which were matched by Thrivent Financial. As always the year began with another successful Souper Bowl event, part of a nationwide effort on NFL Super Bowl Sunday to bring awareness to the issue of hunger. This event resulted in \$1,304.00 being donated to our local Red Cross Food Bank. And then in August, our congregation pulled together to collect donations to support the children of Pastor Pat and Pastor Keith who had been faced with serious illnesses or injuries. We were pleased to be able to present a check for \$4,000.00 to Pastor Pat to support their family.



We also added our support to some community efforts including placing a collection barrel in the narthex for used clothing, shoes, etc. to support the ongoing ministry of HandUp Foundation; participated with a donation of 28 coats to the Coat Ministry conducted by Bethany Methodist Church and Love, INC. and helped the Salvation Army Angel Tree project by providing 22 gifts for local children.

We continued our commitment to 8-11 family and friends of our members who are serving in the military by putting together and mailing care packages twice during the year; raised \$2,113.90 for the American Cancer Society through our participation in Relay for Life; raised \$631.50 for World Hunger during the Crop Walk and sold CD's totaling \$180.00 to support Diana Luscombe who is recovering from a serious car accident.

Within our congregation, we added our Holiday Angels, members of the congregation who signed up to deliver our Easter and Christmas flowers to our shut-ins, conducted our first Holiday Card Shower which collected 100+ Christmas cards for our shut-ins, and put together 3 Holiday Food Baskets for 3 families in our congregation who were grateful for these special gifts.

As busy as we were with all of the above, we also continued our partnership with Pine St. Lutheran in Danville by providing 20+ Love Bags for the Geisinger Children's Hospital; made and provided to local agencies 124 Winter Wrap items; made and distributed several Prayer Shawls, and continued our Mile of Pennies and Campbell's Soup label collections.

We hope to continue our momentum in 2008 and look forward to having new people step forward to head up some of our ongoing projects as well as add new projects to our ministry.

At its June 3, 2007 meeting, the Bequest Task Force Group unanimously decided to make the following recommendation for use of the funds from the Johnson and Yagel bequest monies:



Donate up to \$20,000 (to be added to the previously earmarked \$20,000) to the pavilion fund to bring this project to completion and with the remaining monies (approximately \$530,000) in the Johnson and Yagel bequests, split the funds into thirds for the following purposes:

1. Invest
2. Facility Ministry
3. Church Growth

The committee also suggests that this “thirds” recommendation be set as a standard for any future “unspecified” bequests.

Report of the Congregational Council 2007



The responsibility of the Congregational Council is the general oversight of the life and activities of the congregation. Leading the congregation in stating its mission, long-range planning, setting goals, and priorities are all part of this process. To this end, Council:

- Held a Church Council retreat and invited all the leaders in the church
- Approved hiring Bret Hosterman as our organist
- Approved a one time distribution of \$62,000 from the Bequests:
 - \$20,000 – As our congregational contribution to the Synod
 - \$32,000 – to be distributed to local charities
 - \$10,000 to be given to support ELCA Outreach ministry programs such as World Hunger and/or Missions
- Provided support to the congregation in the following:
 - ⇒ Annual Congregational Meeting
 - ⇒ Approved increase in Church Camp scholarships from 50% to 75%
 - ⇒ Approved delegates Carol Conrad and Stephen Moll to represent the congregation at the Upper Susquehanna Synod Assembly in June. Approved Kellie Brouse as the Alternate delegate.
 - ⇒ Welcomed new members Michael Himes; Frank, Deana, Kyle, Blake, & Courtney Kovilaritch; Karen Lubrecht; Barry Yeager; Nevin & Nancy Mensch; and Rose Walsh to the congregation
 - ⇒ Supported Vacation Bible School which was a success
 - ⇒ Supported the Advent Pageant which was a success
 - ⇒ Held a new and improved Family reunion Sunday this year
 - ⇒ Held Cottage Meetings to allow the congregation to express their opinions on the Pastoral Call and the 2008 Church Budget. This gives the congregation ownership in their Church.
 - ⇒ Supported the development of an Endowment Fund for faithful bequests from those who have passed on and provided guidelines for administering this fund.
 - ⇒ Approved the construction of a handicapped accessible uni-sex restroom
- Called Pastor Pat as our permanent Pastor this year. We are so blessed. Provided faithful and financial support for her family members who were going through some serious health issues.
- We said “Good Bye” to Linda Shipman, Church Secretary, and were led to Lorei Comerer as our new Church Secretary. We are truly blessed.

CONGREGATIONAL MEETING MINUTES

November 18, 2007

Meeting was called to order by Church Council President Kellie Brouse.

First item on the agenda was the 2008 budget. Church Council recommended the Challenge budget of \$152,458, which included \$8,400 in mission and benevolence support. This was an increase of 8.4% over the 2007 budget so the congregational giving would have to increase 8.4% to support this budget. Stephanie Byers seconded the recommendation. There was no discussion from the congregation. Ballots were cast. Recommendation was approved with 53 “yes” votes to 4 “no” votes.

Second item on the agenda was the Bequest Recommendation. The Bequest Task Force recommended and Church Council approved the following recommendation:

The Johnson and Yagel bequests totaling about \$600,000 be divided into three equal parts to be distributed to the Building Fund, the Investment Fund portion of the Endowment Fund, and the Social Missions and Program Fund portion of the Endowment Fund.

Nancy Walters seconded the recommendation. There was no discussion from the congregation. Ballots were cast. Recommendation was approved with 55 “yes” votes to 3 “no” votes.

Third item on the agenda was the resolution to implement the Endowment Fund. Church Council recommended that an Endowment Fund be created to administer the Investment Fund portion and the Social Missions and Program Fund portion of the Johnson and Yagel bequests. In addition the current Leiby Trust would be combined with the Social Missions and Program Fund portion of the Johnson and Yagel bequests. The Leiby Trust had a current value of about \$132,500 and \$104,000 of this was the original bequest. The approximate \$200,000 portion of the Johnson and Yagel bequests is to be invested in the investment fund and only the returns on the investment fund can be used for any purpose (no restrictions) pending approval by the Endowment Fund Administration Committee. The original \$104,000 from the Leiby Trust is to be invested and only the returns on the investment can be used for Social Missions and Program Fund purposes pending approval by the Endowment Fund Administration Committee. The balance of the Leiby trust is earnings and that \$28,500 plus the \$200,000 of the Johnson and Yagel bequests is available for immediate use. All of the earnings in the Endowment Fund will remain fully invested until they are to be used. Frank Hartzel made a motion to accept the recommendation. The motion was seconded by Kellie Brouse. There was no discussion from the congregation. Ballots were cast. The motion passed with 50 “yes” votes and 5 “no” votes.

The fourth item on the agenda was the Property Committee’s recommendation for a new unisex, handicapped accessible restroom. The Property Committee recommended and the Church Council approved the use of money from the Building Fund portion of the Johnson and Yagel bequests to build a unisex, handicapped accessible restroom in the east-end of the cloakroom at a cost of \$12,191. The new restroom would also include an infant-changing table. Nancy Walters seconded the recommendation. There was a short congregational discussion concerning explanations of some details. The ballots were cast. Recommendation was approved with 51 “yes” votes and 3 “no” votes.

The fifth item on the agenda was the Property Committee’s recommendation for new lighting fixtures in the sanctuary at a cost not-to-exceed \$60,000. The Church Council approved the recommendation and the use of money from the Building Fund portion of the Johnson and Yagel bequests. A firm price for the lighting was not yet available because some details needed to be resolved. George Bolich seconded the recommendation. There was as short congregational discussion concerning energy efficiency, energy cost, new wiring, and dimmers. The ballots were cast. The recommendation was approved with 48 “yes” votes and 9 “no” votes.

The sixth and last item on the agenda was the election of new council members to replace the term expiration of Rose Deaner, Carol Conrad, and Kellie Brouse. The Nominating Committee recommended with the Church Council's approval Stephanie Byers, Donna Spear, and Tim Walsh. Frank Hartzel made a motion that the ballot be closed. Nancy Walters seconded the motion. No ballots needed to be cast. Nominees were accepted without opposition.

Pastor Pat thanked all people who worked so diligently and faithfully on the items presented and the congregation for their faithful participation.

Laurie Fisher made a motion to adjourn the meeting. It was seconded by Nancy Walters. Meeting adjourned.
